## **SALIENT FEATURES FOR ELIGIBILITY TO APPLY FOR POST PUBLICATION REVIEW**

### **1) General Rules for 3-Year LL.B. Examination Under Semester System :**

- i)** A candidate may apply for Post Publication Review of his / her answer-scripts in a maximum number of two theoretical papers (irrespective of marks in the papers asked for review) in each Semester Examination in the prescribed form and manner and on submission of requisite fees within the date as per notification to be issued by the office of the Controller of Examinations, provided the candidate must have to secure a minimum aggregate of **40%** in aggregate in the remaining theoretical papers not asked for review of the particular semester examination.
- ii)** Such applications must be checked and verified by the concerned Department of Law / Colleges in regard to eligibility of the candidates applying for review. All such applications must be forwarded by the Head of the concerned Department, B.U., / Principal / Teacher -in-Charge of the concerned College / Department.
- iii)** Incomplete and faulty application is liable to be rejected without assigning any reason and without any intimation to the candidate / concerned college.
- iv)** There will be no scope of Post Publication Review of practical paper(s) / Term Paper(s) / Project Paper(s) / Internal Assessment / Viva-Voce / Field Report / Survey Report / Moot Court room exercise / Court Visit Report etc. if any.
- v)** Under no circumstances fees for Post-Publication Review once paid be refunded.

### **2) General Rules for 5-Year Integrated B.A. LL.B. Examination Under Semester System :**

- i)** A candidate may apply for Post Publication Review of his / her answer-scripts in a maximum number of two theoretical papers irrespective of marks in the papers asked for review in each Semester Examination in the prescribed form and manner and on submission of requisite fees within the date as per notification to be issued by the office of the Controller of Examinations, provided the candidate must have to secure a minimum aggregate of **35%** in aggregate in the remaining theoretical papers not asked for review of the particular semester examination.
- ii)** Such applications must be checked and verified by the concerned Department of Law / Colleges in regard to eligibility of the candidates applying for review. All such applications must be forwarded by the Head of the concerned Department, B.U., / Principal / Teacher -in-Charge of the concerned College / Department.
- iii)** Incomplete and faulty application is liable to be rejected without assigning any reason and without any intimation to the candidate / concerned college.
- iv)** There will be no scope of Post Publication Review of practical paper(s) / Term Paper(s) / Project Paper(s) / Project Paper(s) / Internal Assessment / Viva-Voce / Field Report / Survey Report / Moot Court room exercise / Court Visit Report etc. if any.
- v)** Under no circumstances fees for Post-Publication Review once paid be refunded.

### **3) General Rules for LL.M Examination Under Semester System :**

- i)** A candidate may apply for Post Publication Review of his / her answer-scripts in a maximum number of two theoretical papers (irrespective of marks in the papers asked for review) in each Semester Examination in the prescribed form and manner and on submission of requisite fees within the date as per notification to be issued by the office of the Controller of Examinations, provided the candidate must have to secure a minimum aggregate of **45%** in aggregate in the remaining theoretical papers not asked for review of the particular semester examination.
- ii)** There will be no scope of Post Publication Review/Scrutiny of practical paper(s) / Term Paper(s) / Project Paper(s) / Internal Assessment / Viva-Voce / Moot Court report / Court Visit Report etc. if any.
- iii)** Post Publication Review and Scrutiny of the same paper(s) shall not be allowed.
- iv)** Any addition or subtraction of marks by the University after Post Publication Review should be treated as final and will be binding on the candidate. No further application for consideration of Review result will be entertained.
- v)** Incomplete and faulty application is liable to be rejected without assigning any reason and without any intimation to the candidate / concerned college.
