**RULES REGARDING POST PUBLICATION REVIEW OF ANSWER SCRIPTS AT THE
M.A. / M.SC. / M. COM. (SEMESTER) EXAMINATIONS**

- 1. The Candidate will not be allowed to apply for P.P.Review for paper(s) appeared at the Repeat examination.**
- 2. A Candidate may apply for Post-Publication Review of his/her theoretical answer scripts in a maximum number of 50% of total theoretical papers appeared in each semester.**
- 3. For the purpose of Post-Publication Review of scripts, a full or a half paper shall be treated as a paper.**
- 4. For review of Script(s) a candidate must have to secure a minimum aggregate of 35% of the total marks in theoretical part of the particular semester examination irrespective of marks in the Paper(s) asked for review.**
- 5. There will be no scope of Post-Publication Review of Practical Paper(s)/ Term Paper(s)/ Project Paper(s)/ Internal Assessment/ Viva-voce/ Field Report/ Survey report, if any.**
- 6. For each paper, full or half, a fee of Rs.150/- is to be paid in cash along with the application, in the Cash Section of the University. I.P.O. / D.D. / Cheque will not be accepted.**
