**RULES REGARDING POST PUBLICATION REVIEW OF ANSWER SCRIPTS AT THE
TWO YEARS B.ED COURSE UNDER SEMESTER SYSTEM EXAMINATIONS**

1. The Candidate will not be allowed to apply for P.P. Review for course(s) appeared at the Repeat examination.
2. A Candidate may apply for Post-Publication Review of his/her theoretical answer scripts in a maximum number of Two theoretical Paper/ courses appeared in each semester provided that he/she has secured at least 40% of Marks in the remaining papers.
3. There will be no scope of Post-Publication Review of Practical Course(s)/ Term Paper(s) / Project(s) / Internal Assessment/ Viva-voce/ Field Report/ Survey report, if any.
4. For each course a fee of Rs.150/- is to be paid in cash along with the application, in the Cash Section of the University (I.P.O. / D.D. / Cheque will not be accepted).
