## Notification for 2<sup>nd</sup> round of counselling for admission to 3-yr. LL.B. (H) Course of Studies for the session 2018-20

In continuation of our earlier notices no. No.: FC/PG(A)/ LL.B.(H)/Admn./2018-20/415, dated 12.02.2018 & No.: FC/PG (A)/ LL.B. (H)/Admn./2018-20/422, dated 15.02.2018, this is to notify for all concerned that the next round of counselling for admission to the 3-yrs. LL.B. (H) Course of Studies for the session 2018-20 will be held on 27.02.2018 from 12 noon at Allumni Hall, Golapbag, the University of Burdwan, for admission to AMEX LAW COLLEGE, Parbirhata, Natun Bazar, Sadarghat Road, Purba Bardhaman, 713103, GEORGE SCHOOL OF LAW, 114 G.T. Road, Konnagar, Hooghly, 712235 (vacancy position is mentioned below) and for a few seats lying vacant in Burdwan University Campus, Bengal Law College and Hooghly Mohsin College, if any.

The candidates shall have to report to the counselling hall by 11.30 a.m. sharp. All the intending candidates are advised to attend the counselling as per the schedule mentioned above. The candidates who will be selected for AMEX LAW COLLEGE or GEORGE SCHOOL OF LAW and Bengal Law College, Bolpur, Shantiniketan, will have to pay Rs 6000/- (Rupees six thousand only) as admission fees initially on the date of counselling and later on they have to take admission by providing other admissible fees on the dates as will be notified by the college authorities. Selected candidates, if not formally takes admission/ pays admissible fees within the stipulated period, his/her admission will be treated as cancelled. The candidates who were absent on the date of first counselling (30.01.2018) will not be allowed to take part in the counselling programme. **Candidates having rank from 125 onwards in the broad merit list of LL.B. Admission (2018-20) are eligible to participate in the counselling.**
