## NOTIFICATION

The counseling for admission to the Ph. D. Programme 2018, and State Funded Fellowship 2018 as per the following provisional short merit list of the candidates, will be held **on 11.07.2018 from 12 noon in the Alumni Hall, Golapbag, B. U. as per the following schedule.** The candidates have to attend the counseling programme compulsorily along with all academic credentials either personally or through **his/her authorized representative**, failing which their selection will liable to be cancelled. Selection will be made strictly on the basis of merit. After verification of documents, **admission will be done at the office of the Secretary, Faculty Council (Arts etc.), 3<sup>rd</sup> Floor, composite Arts Building, Golapbag, B.U. on 12.07.2018 and 13.07.2018 from 12 noon to 3 p.m.** The mere fact that any name has been published in the list does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students or any mistake on the part of the University, detected at any stage before or after the admission. As per the reservation rules vide Govt. Order No.: *07-Edn (U)/IU-89/13.- dated. 2nd January, 2014* "for admission to different courses, an SC or ST candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 25% of the marks obtained by the last candidate of the general category. In case of OBC-A and OBC-B the candidates getting admission should have obtained in the previous examination, qualifying marks not lower by more than 10% from the marks obtained by the last candidate of the general category." Seats are limited and will be available on the basis of merit and hence, mere participation in the counseling does not ensure seats to the candidates as number of seats are lesser than the number of applicants. Selected **Candidates have to deposit a demand draft of Rs. 3000/- (Rupees Three thousand only) for Ph. D. Programme/ State Funded Fellowship. The demand draft is to be drawn in favour of "The Finance Officer, the University of Burdwan", payable at S.B.I. Burdwan University Branch.**
