Applicable for eligible candidates (remaining candidates after Phase-I and II admission) who applied for LLM and MBA/MBA(HR)/ MBA(Tourism) offered by different centres of learning (Colleges and Golapbag Campus for LLM and three MBA programmes in multiple centres of Learning in three PG departments at Golapbag Campus of The University of Burdwan (BU).

The candidates should take note of the following instructions:

1. The session is being conducted **only** for merit-based option/selection of centre of learning. After this session, the list of selected candidates will be prepared in the light of the vacancy position. Document verification will be carried out later on after the conclusion of the session and payment of admission fees through on-line mode for the respective centre of learning and after the commencement of classes.

2. **All candidates as per the rank stated above who intend to study in multiple centres of learning should attend the session irrespective of whether they have previously given their option through online application either by email or by other means. The candidate or his/her authorised representative should positively attend the session.**

3. Once the merit-based selection of option of centre of learning is completed, based on vacancy position, payment link for payment of the requisite admission fees will open for the selected eligible candidates through the online link that will be available in the Post Graduate Admission (Arts) page on the university website. Selected candidates should log on to payment portal by inserting SP Transaction ID provided along with their name.

6. Payment of admission Fees is to be made through Net Banking/Debit Card/Credit Card/Offline bank Challan generated through online process.

7. Candidates should ensure the generation of e-receipt of successful payment generated in the online system or SMS sent from SabPaisa to their registered mobile no. or through email to their registered e-mail id of Payment Success. Please remember that the receipt of SMS from own bank may not ensure successful payment to the designated bank account.

8. The university will not take the responsibility of any payment failure caused due to network problems.

9. The broad merit list has been prepared based on system generated data without actual document verification. Candidates are therefore requested to verify their graduation honours marks and in case of any discrepancy/ difference with the actual marks obtained, the same must be immediately brought to the notice (email: pgadmissionarts2019@buruniv.ac.in) before proceeding with the online admission.

10. **ALL ADMISSIONS ARE PROVISIONAL.** The mere fact that any name has been published in the admission list does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order at the time of verification of documents. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.

11. If a candidate is found, before or after admission, **not** having the **minimum eligibility of admission in post graduate courses of The University of Burdwan**, then university will have the right to cancel his/her admission without taking the responsibility of refund of his/her admission fees. Candidates not possessing the minimum eligibility for admission are advised not to proceed or submit or upload their pending academic detail.

12. Candidates will be enlisted based on the merit-based selection of centre of learning and on the basis of the approved intake of the colleges and vacancy position at BU campus.

13. The selected candidates should report to their respective departments with the e-receipt of their admission Fees on the **stipulated date to be notified in the website** for document verification and commencement of classes. Candidates selected for BU campus should report to the respective department on or one day after the payment of admission fees.

14. All the candidates will have to produce and submit self-attested photocopies of **all** testimonials including the relevant certificates and final honours mark sheet **on the date of document verification**, failing which their admission to Post Graduate courses will be cancelled. All eligibility criteria will be checked during document verification. If, at the time of document verification, the marks obtained by the candidate doesn't match with the marks shown in the merit list, the admission of the candidate is liable to be cancelled.
