Admission Notification: Phase III: LLM, MBA/MBA(HR)/MBA(Tourism) and Political Science

PHASE-III: ONLINE ADMISSION TO COMMENCE FROM 10.09.2019

On the basis of the merit-based selection of centre of learning, the payment link for the concerned candidates as per the merit list for admission in **LLM**, **MBA/MBA(HR)/MBA(Tourism)** and **Political Science** for the session 2019-2021 (Phase-III) will be open from **10.09.2019**.

The students should take note of the following points before making payment of admission Fees:

- 1. Payment of Admission Fees will <u>start from 10th September, 2019</u> through the online link that will be available in the Post Graduate Admission (Arts) page on the university website. Candidates should log on to payment portal by inserting SP Transaction ID provided alongwith their name.
- 2. The link will remain open till 5 p.m. on 14th September, 2019.
- 3. Payment of admission Fees is to be made through Net Banking/Debit Card/Credit Card/Offline bank Challan generated through online process.
- 4. Students should ensure the generation of e-receipt of successful payment generated in the online system or SMS sent from SabPaisa to their registered mobile no. or through email to their registered e-mail id of Payment Success. Please remember that the receipt of SMS from own bank may not ensure successful payment to the designated bank account.
- 5. The university will not take responsibility of any payment failure caused due to network problems.
- 6. **ALL ADMISSIONS ARE PROVISIONAL**. The mere fact that any name has been enlisted in the admission list based on merit and the link has been opened for the concerned candidate, does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order at the time of verification of documents after the commencement of classes. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.

- 9. If a candidate is found, before or after admission, **not** having the **minimum eligibility** of admission in post graduate courses of The University of Burdwan, then university will have the right to cancel his/her admission without taking responsibility of refund of his/her admission fees. Candidates not possessing the minimum eligibility of admission need not proceed or submit or upload their pending academic detail.
- 11. Candidates whose payments are successful should contact their respective centre of learning (department) for instruction regarding document verification and commencement of classes.
- 12. All the candidates will have to submit self-attested photocopies of all testimonials including final honours mark sheet and other documents on the date(s) to be notified by the centre of learning (college/university department), failing which, their admission to Post Graduate courses will be cancelled. Document verification will be carried out after the commencement of classes. If, at the time of document verification, the marks obtained by the candidate doesn't match with the marks shown in the merit list, the admission of the candidate is liable to be cancelled.
