The candidates should take note of the following instructions:

1. The session is being conducted **only** for subject-wise merit-based selection for the vacant seats. Document verification will be carried out later on after the conclusion of the session, after payment of admission fees through on-line mode for the respective centre of learning.
2. **All concerned candidates** as per their rank in the merit list as stated above should attend the session and in case a candidate is unable to attend, he/she should his/her **authorised representative** for the session.
3. Once the session for merit-based selection is completed, payment link for payment of the requisite admission fees will open through the online link that will be available in the Post Graduate Admission (Arts) page on the university website. Candidates should log on to payment portal by inserting SP Transaction ID provided along with their name.
4. Payment of admission Fees is to be made through Net Banking/Debit Card/Credit Card/Offline bank Challan generated through online process.
5. Candidates should ensure the generation of e-receipt of successful payment generated in the online system or SMS sent from SabPaisa to their registered mobile no. or through email to their registered e-mail id of Payment Success. Please remember that the receipt of SMS from own bank may not ensure successful payment to the designated bank account.
6. The university will not take the responsibility of any payment failure caused due to network problems.
7. The broad merit list has been prepared based on system generated data without actual document verification. Candidates are therefore requested to verify their graduation honours marks and in case of any discrepancy/ difference with the actual marks obtained, the same must be immediately brought to the notice (email: pgadmissionarts2019@buruniv.ac.in) before proceeding with the online admission.
8. **ALL ADMISSIONS ARE PROVISIONAL.** The mere fact that any name has been published in the admission list does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order at the time of verification of documents. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.
9. If a candidate is found, before or after admission, **not** having the **minimum eligibility of admission in post graduate courses of The University of Burdwan**, then university will have the right to cancel his/her admission without taking the responsibility of refund of his/her admission fees. Candidates not possessing the minimum eligibility for admission are advised not to proceed or submit or upload their pending academic detail.

10. The selected candidates should report to their respective departments with the e-receipt of their admission Fees **immediately after** payment of admission fees on the **stipulated date to be notified in the website** for document verification and commencement of classes.

11. All the candidates will have to produce and submit self-attested photocopies of **all** testimonials including the relevant certificates and final honours mark sheet **on the date of document verification**, failing which their admission to Post Graduate courses will be cancelled. All eligibility criteria will be checked during document verification. If, at the time of document verification, the marks obtained by the candidate doesn't match with the marks shown in the merit list, the admission of the candidate is liable to be cancelled.
