### **The candidates should take note of the following instructions:**

1. The session will be conducted **only** for merit-based option/selection of M. Phil. Programme 2019-21 or Ph. D. Programme 2019 on the basis of their seniority of merit. Document verification will be carried out later on, after the conclusion of the session and payment of admission fees for provisionally selected candidates will have to be done through on-line mode. All candidates have to attend the session compulsorily irrespective of the fact that they have chosen their programme during their submission of online form. The candidate or his/her authorised representatives should attend the programme compulsorily. ***The candidates who had been admitted earlier to the programmes as per their option are directed not to report for the said session.***

2. Once the merit-based selection of option is completed, payment link for online payment of the requisite admission fees will open through the online link that will be available in the university website. Candidates should log on to payment portal by inserting SP Transaction ID, provided along with their name. Payment of admission Fees is to be made through Net Banking/Debit Card/Credit Card/Offline bank Challan generated through online process.

3. Candidates should ensure the generation of e-receipt of successful payment generated in the online system or SMS sent from SabPaisa to their registered mobile no. or through email to their registered e-mail id of Payment Success. Please remember that the receipt of SMS from own bank may not ensure successful payment to the designated bank account.

4. The university will not take the responsibility of any payment failure caused due to network problems.

5. The broad merit list has been prepared based on system generated data without actual document verification. Candidates are, therefore, requested to verify the credibility of their academic credentials, discrepancies if any the same must be immediately brought to the notice (email: [secretary\\_arts@buruniv](mailto:secretary_arts@buruniv)) before proceeding with the online admission.

6. **ALL ADMISSIONS ARE PROVISIONAL.** The mere fact that any name has been published in the admission list does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order at the time of verification of documents. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.

7. If a candidate is found, before or after admission, **not** having the **minimum eligibility of admission in programmes mentioned above**, then university will have the right to cancel his/her admission without taking the responsibility of refund of his/her admission fees.

8. Selected candidates should report to their respective departments with the e-receipt of their admission Fees for attending the classes.

9. All the candidates will have to produce and submit self-attested photocopies of **all** testimonials including the relevant certificates/ mark-sheet **to the office of the concerned department**, failing which their admission will be cancelled.

10. All eligibility criteria will be checked during document verification. If, at the time of document verification, the marks obtained by the candidate don't match with the marks shown in the merit list, the admission of the candidate is liable to be cancelled.
