Admission Notification **(Ph.D. Programme 2019 in Education.)**

The following candidates are provisionally selected (as per the rank in the broad merit list) for admission to the Ph.D. Programme 2019 in Education.

The students should take note of the following points before making payment of admission Fees

1. Online Payment of Admission Fees will start from 06.07.2020 (online, 8 pm onwards) through the online link that will be available in the Online M.Phil./Ph.D. Admission (Arts), 2019 page on the university website. Candidates should log on to payment portal by inserting SP Transaction ID provided alongwith their name.
2. The link will remain open till 5 p.m. on 10.07.2020.
3. Payment of admission Fees is to be made through Net Banking/Debit Card/Credit Card/Offline bank Challan generated through online process.
4. Candidates should ensure the generation of e-receipt of successful payment generated in the online system or SMS sent from SabPaisa to their registered mobile no. or through email to their registered e-mail id of Payment Success. Please remember that the receipt of SMS from own bank may not ensure successful payment to the designated bank account.
5. The university will not take the responsibility of any payment failure caused due to network problems.
6. Candidates allotted under both Unreserved and reserved categories will have to exercise their specific choice of seat from the dropdown menu which will be available in the online payment form. In case a candidate is under a reserved category he/she should click on his/her specific option that is relevant for him/her (i.e. SC/ST/OBCA/OBCB/DA).
7. The merit list has been prepared based on system generated data without actual document verification. In case of any discrepancy/ difference with the actual marks obtained, the same must be immediately brought to the notice (email: secretary_arts@buruniv.ac.in) before proceeding with the online admission.
8. ALL ADMISSIONS ARE PROVISIONAL. The mere fact that any name has been published in the admission list does not by itself ensure admission of the candidate concerned unless his/her original credentials are found in order at the time of verification of documents after the commencement of classes. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data or erroneous entry of the superiority in position of a candidate in the merit list, is detected at any stage, before or after the admission.

9. If a candidate is found, before or after admission, not having the minimum eligibility of admission in Ph.D. Programme 2019 of The University of Burdwan, then university will have the right to cancel his/her admission without taking the responsibility of refund of his/her admission fees. Candidates not possessing the minimum eligibility for admission are advised not to proceed or submit or upload their pending academic detail.

10. Seats remaining vacant after the expiry of payment period will be filled up through a second list which will be published after the completion of admission of candidates enlisted in the first list.

11. Commencement of classes/ online classes will be notified later on for the candidates who have taken admission from the first list. These candidates should report to their respective departments with the e-receipt of their admission Fees.

12. Admission will be confirmed after the verification of all testimonials of the candidates. All the candidates will have to produce and submit self-attested photocopies of all testimonials including the relevant certificates along with e-receipt of online payment on the date of document verification, failing which their admission to Ph.D. Programme 2019 will be cancelled. All eligibility criteria will be checked during document verification which will be carried out after the commencement of classes. If, at the time of document verification, the marks obtained by the candidate don't match with the marks shown in the merit list, the admission of the candidate is liable to be cancelled. All in-service applicants (including those intending to prosecute Ph.D. as part-time scholar) have to submit N.O.C. from their employer (Appropriate authority) at the time of admission.
