Complete applications in the prescribed forms along with photocopies of two sets of all credentials must reach the office of the Registrar latest by 15/02/2018 (Through proper channel, in case of already employed candidates). No TA/DA is admissible for attending the interview. It should be noted that possession of minimum eligibility shall not confer any right to be called for interview. Incomplete applications will be rejected outright.

#### a. Essential Qualification:

- (i) Uniformly good academic record with a Master's Degree with minimum 55% marks or its equivalent grade in the point scale wherever grading system is followed.
- (ii) At least 10 years' of experience as Lecturer / Assistant Professor in the AGP of Rs. 6,000/- and above with experience in educational administration in Academic Institutions like University, Research Establishment and/or in an institute of higher learning of which 5 (five) years must be in a University or in an Institute of Post Graduate Study.

10 (ten) years'administrative experience, of which 5 years shall be as Assistant Registrar or equivalent post.
