NOTIFICATION

In view of call given by some political parties for a 6-hour bandh / strike from 06-00 a.m. to 12 noon on 13-04-2018, it is hereby notified for information of all concerned that the University will remain open on 13-04-2018. All sections of employees (teachers, officers and non-teaching staff) should report for duty on that date and **no Casual leave for absence either in the first half of the day or in the second half or for the whole day nor any other leave** shall be granted to any employee on the said date i.e on 13-04-2018 and no extension of leave shall be allowed. Absence of employees on that date will be treated as **dies non** and **no salary will be admissible unless such absence is covered by grounds as mentioned below:** -

- Hospitalisation of the employee,
- Bereavement in the family,
- Severe illness and absence continuing prior to 12-04-2018,
- Employees who had been on Child Care Leave, Maternity Leave, Earned leave and Commuted Leave on medical ground sanctioned prior to 12-04-2018.

It should be remembered that dislocation /disruption of vehicle traffic will not be a reason for granting leave.

Where the absence(s) is/ are not covered by any of the above mentioned reasons and the leave has not been approved, the same will be treated as **dies non** and **no salary will be admissible for that day i.e. on 13-04-2018.**

All Heads / Controlling Officers are hereby requested to send department-wise absentee report on that date, as aforesaid within 01-30 p.m. If any employee remains absent on that date, he/she will be asked to explain why action would not be taken against him/her for such unauthorized absence. On receipt of satisfactory reply, leave due and admissible may be granted on production of documentary evidence on the ground mentioned above.

All sections of employees (Teachers, Officers and Non-teaching employees) are directed to comply with the said order strictly.

This notification is issued pursuant to the memorandum bearing No. 2364-F(P₂) dated 12-04-2018 issued by Finance Dept., Audit Branch, Govt. of West Bengal.
