Eligibility: For admission to 5- Year B.A. LL.B (Hons.) Course, every candidate shall have to pass the **Higher Secondary** Examination under (10 + 2) pattern or its equivalent examination securing **not below 45%** of the total marks in case of general category and **40%** of the total marks in case of SC and ST applicants.

Age Limit: No age limit but the entire process including admission to the course shall abide by the decision of the Hon'ble Supreme Court against WP(Civil) No.- 1023/2016 pending before it.

Submission of Application Forms: Duly filled in downloaded application form, **accompanied** by a **DD of Rs. 250/-** (ie. cost of application form) drawn in favour of the Finance Officer, B.U., payable at SBI, B.U. Branch, Burdwan, along with the Self attested **photo copies** of **Admit Card** (MP or its equivalent exam.), **Mark Sheets** of all the Public Examinations passed and **SC/ ST Certificate** (for relaxation in marks) and the NOC from the competent authority(in case of in-service candidates), shall be submitted, either personally or by authorized representative, to the **Office of the Secretary, Council for U.G. Studies** in Arts, Sc., Comm. etc., B.U., Rajbati, Burdwan on or before **12.07.2019** (except Saturday, Sunday & holidays).

5-Year B.A. LL.B. (Honours) Course of Studies is taught, on **self- financed** basis, only in **Bengal Law College** (BITM Campus), Gopalnagar, Sriniketan Bypass, P.o.Doranda, Dist.Birbhum,Pin-731236, 9007030108 and **AMEX Law College**, Nawabab Hat, Suri Main Road, Opposite of Uttara Bus Stand, P.o. Fagupur, Dist.-Burdwan, Pin-713104, (9474915124, 9775777797) affiliated to the University of Burdwan. A Candidate concerned, while prosecuting a regular course of study in Law under this University, shall neither take up nor shall be permitted to take up any other course simultaneously. Candidates must verify **eligibility** before collecting the application forms.

No. of Seats: 80 in Bengal Law college. & 60 in AMEX Law College.

Course Fee: Rs. 25000/- per annum

Availability of Application Forms: Application forms for admission to **5-Year B.A. LL.B. Hons. Course of Studies** will be available, **only on the university website** (<http://www.buruniv.ac.in>), not in any affiliated Law College/ Institute on and from **17.06.2019** to **12.07.2019**. Form no. will be allotted by the office of the undersigned at the time of submission of form. Candidates are advised to go through the duly approved list of recognized Board/Council/ University Institution attached herewith, before filling up of application form for admission to the Courses in the Colleges affiliated to the University of Burdwan in the Year 2019-20.

Eligibility: For admission to 5- Year B.A. LL. B (Hons.) Course, every candidate shall have to **pass the Higher Secondary** Examination under 10 + 2 pattern or its equivalent examination securing **not below 45%** of the total marks in case of general category and **40%** of the total marks in case of SC and ST applicants.

**Note: In the calculation of percentage of marks at (10+2) level, marks of the best five Subjects, available in the mark sheet, will be considered. Marks of Environment Studies may be considered among the best five Subjects if it is found under Compulsory Elective/Optional Elective in the Mark Sheet.*

Age Limit: No age limit but the entire process including admission to the course shall abide by the decision of the Hon'ble Supreme Court against WP(Civil) No.- 1023/2016 pending before it.

SC/ST candidates of domicile state are entitled to get the marks relaxation facility i.e. SC/ST candidates hailing from states other than West Bengal are not eligible for such benefits and they will be treated as General category candidates. Candidates, who are seeking relaxation in marks under SC/ ST category, must enclose self attested photo copy of the Certificate **obtained** from the competent authority to authenticate their claim. Relevant certificate must conform to **THE W.B. GOVT. MEMO NO. 1813-BCW / MR-94/11** dated Kolkata, **20th June, 2011**.

The certificate must be obtained from one of the authorities listed below:

- i) Deputy Director, Backward Classes Welfare, West Bengal and Commissioner, Backward Classes Welfare, West Bengal in case of candidates claiming to be Scheduled Caste or Scheduled Tribe residing in any part of West Bengal.
- ii) Deputy Commissioner of Land Revenue, Kolkata, Collector of Stamp Revenue, Kolkata, Metropolitan Magistrate, Kolkata, Addl. Chief Metropolitan Magistrate, Kolkata, Chief Metropolitan Magistrate, Kolkata, 1st Class Stipendiary Magistrate, Executive Magistrate, Sub-Divisional Magistrate, Sub-Divisional Officer, Deputy Collector, Addl. District Magistrate, Collector and District Magistrate with their respective jurisdictions in case of candidates claiming to be Scheduled Caste or Scheduled Tribe and ordinarily residing within such jurisdictions.

Submission of Application Forms: Duly filled in downloaded application form, **accompanied** by a **DD of Rs. 250/-** (ie. cost of application form) drawn in favour of the Finance Officer, B.U., payable at SBI, B.U. Branch, Burdwan, along with the attested **photo copies** of **Admit Card** (MP or its equivalent exam), **Mark Sheets** of all the Public Examinations passed and **SC/ ST Certificate** (for relaxation in marks) and the **NOC** from the competent authority(in case of in-service candidates) , shall be submitted, either personally or by representative, to the **Office** of the **Secretary, Council** for **U.G. Studies** in Arts, Sc., Comm. Etc., B.U., Rajbati, Burdwan on or before **12.07.2019** (except Saturday, Sunday & holidays). Submission of applications by post should be avoided.

Mode of Selection for Admission: Selection for admission to the course shall be made strictly on the basis of **merit** to be determined by the **percentage of marks** obtained at the **Higher Secondary** or its equivalent Examination under 10 + 2 pattern. In case of same percentage of marks of two or more candidates, marks of English at the **Higher Secondary** or its equivalent Examination, under 10 + 2 pattern, will be compared. Marks of English at the **Madhyamik Pariksha** or its equivalent examination will be considered as the third criterion, if needed.

Publication of List: Notification of publication of **Provisional Rank List** will be available only on the University Website (<http://www.buruniv.ac.in>) on **19.07.2019** and admission will be held on **25.07.2019** & **26.07.2019** in the respective colleges.

Class Attendance: If a student concerned fails to attend the minimum of 70% of the total lectures delivered in a semester, he/ she shall not be allowed to appear in that examination,

Provided that if a student of semester-I fails to attend the requisite minimum number of lectures delivered as mentioned, shall not get readmission and he/ she shall have to take admission afresh,

Provided that from the second semester onward, if a candidate is declared discollegiate due to shortage of required no. of attendance, he/ she may be allowed to take readmission in that semester on the recommendation of the appropriate authority.

Last date of submission of application forms: 12.07.2019 (upto 3 pm).

Tentative date of commencement of classes : 29.07.2019.
