Candidates are advised to follow the information given below :

1. As per decisions, taken by the Executive Council at its meeting held on 27.06.2019, 80:20 ratio for Home University Students and Other University Students, has been relaxed in case of admission to B.Ed. Programme (2019-21) in Self-financed B.Ed. Colleges under B.U. As a result no separate provisional rank lists (method subject wise) for the fresh applicants of B.U. and O.U. will be available. A combined provisional rank lists (method subject wise) for the fresh applicants and Group of method subjects wise provisional rank lists for Deputed applicants are hereby available for admission to this programme through online.
2. The mere fact that any name, published in the provisional rank lists, does not by itself ensure admission of the candidate concerned unless his/her original testimonials are found in order during verification. Verification of testimonials of the admitted candidates will be done after the commencement of classes.
3. If any Fresh Candidates submitted his or her online application form but final result of Bachelors Degree not yet published, he/ she is advised not to get himself/ herself admitted even though his/her name is found in the provisional rank list. Otherwise he/she may be in trouble at any stage.
4. If any candidates (Deputed/ fresh) submitted his or her online application form as a candidate of DA category but failed to attend the Medical Board as per announced schedule (11.06.2019 & 05.07.2019), he/ she would not get age relaxation and would be treated as a candidate of General category (i.e. age 38 years as on 30.06.2019 and eligibility 50% marks either in Bachelor's degree and/ or in Masters degree) or SC/ST category (i.e. age 38 years as on 30.06.2019 and eligibility 45% marks either in Bachelor's degree and/ or in Masters degree) as the case may be.
5. If it is found in the provisional Rank Lists that any candidate of a method subject is allotted to a college, where that method subject is not available, such a candidate is advised not to get himself/ herself admitted to the programme. In this case, candidates are advised to inform the matter to the undersigned through mail.
6. As per order of the NCTE, vide no. ER-272.14.8/ERCAPP1268/B.Ed./2019/60787, dated, 18.06.2019, total intake of East West Education Institute, Talit, Burdwan, has been reduced from 100 to 50 (one basis unit). Accordingly method subject wise/ group of method subjects wise intake has been revised.
7. Date of provisional admission through online : **25.07.2019, 26.07.2019, 27.07.2019 & 29.07.2019** and **payment of admission fees (Rs. 20,000/-)** should be done through **Credit Card, Debit Card, Net Banking and Allahabad Bank e-challan**.
8. Date of commencement of classes : **31.07.2019**.
9. A revised seat matrix will be made available on the **University Website (www.buruniv.ac.in)** on **07.08.2019** for the **wait listed Fresh applicants**. In this connection wait listed Fresh applicants are requested to put their **fresh choice of colleges** as per revised seat matrix, in the respective link on the **University Website (www.buruniv.ac.in)** from **07.08.2019 to 09.08.2019**.
10. A good number of applications of Fresh / Deputed applicants of different method subjects have been cancelled due to lack of **essential data/ wrong data** and the list of those applicants is hereby available.
