3. **MOCK TRIALS:** The selected team participated in practice moot rounds before a panel of faculty members and Alumni, simulating the actual competition environment.
4. **RESEARCH SUPPORT:** Access to online legal databases such as SCC Online was provided for efficient legal research.

TEAM COMPOSITION AND FACULTY INVOLVEMENT:

A dedicated team of three students from the department of law was selected through internal screening and training process. The team comprised of Two speakers and one researcher. The team was mentored by Monalisa Saha with active cooperation from other faculty members. MOOT PROBLEM

1. The Republic of Faddyland is the fifth most populated country in the world. It has an extremely vibrant economy and ranks as the 8th largest growing economy. The country has a quasi-federal structure with 25 states and 5 centrally administered units. The Union Government has exclusive jurisdiction over matters such as water bodies, forest, external affairs, defence, etc., and also has primacy over states in certain matters enumerated in the Constitution of Faddyland.
2. There is a state in Faddyland called Bongorajjo bordering alongside another country called, Jamladesh on its east. Except for the fact that the inhabitants of Bongorajjo and Jamladesh happen to be in different sovereign countries, they are very similar in their practice of the Islam religion, Bengali language, food habits and other cultural attributes. Because of this shared similarity there have been very less security issues that have come up between the two across the rather porous border.
3. There is also the River Dhiraj that flows from Jamladesh in the East to Bongorajjo in the West. The border is heavily forested area on either side and has been a source of livelihood for the Yulur Tribe that inhabits a large portion of Bongorajjo. A natural riverine border is formed due to the River Dhiraj. The main economic activity of the Yulur tribe was agriculture and they were heavily dependent on the Dhiraj River and the forest for meeting other needs of sustenance.
4. As far back at the 3rd Century AD Bongorajjo, previously called Jameelrajjo was ruled and inhabited by the Yulur Tribe. The customs and language of the Yulur Tribe, now living in the forested lands in Bongorajjo is unique and distinguishable from the rest of the inhabitants who live in the plains of Bongorajjo.
5. Jameelrajjo, like the rest of Faddyland, was invaded and also colonized during different periods in history. There have also been instances of marriages between the Yulur tribe and other inhabitants of Faddyland but the instances are very few. However, the Yulur people have managed to preserve their distinct culture all

throughout, and they voluntarily decided to be part of Faddyland when it attained independence from the colonial rule.

6. As part of the country's development initiative the Central Government of Faddyland sought proposal from all interested persons to come up with industry and start up plans. One such applicant was Mr. Rajat Yulur, presently located in another state of Faddyland, Mumbaeer, who submitted a proposal amongst other applicants to set up an Alcohol brewing plant, Yulur Alcohol Pvt. Ltd, in the forested portion of Bongorajjo. The Central Government selected Mr. Yulur's proposal and passed a notification under the Land Acquisition, Rehabilitation, and Resettlement Act, 2013 to acquire land for Mr. Yulur's private company that shall be brewing Alcohol in Bongorajjo.
7. The Central government offered a rehabilitation package to around 30% of the Yulur Tribe living in the forested land of Bongorajjo on which the proposed Alcohol Plant was to come up. The tribe members were not happy with the offer and refused to accept the same. However, the Central government offered another hefty compensation in addition to providing them with another land and required them to move to other demarcated locations in the plains of Bongorajjo saying that under the Land Acquisition, Rehabilitation and Resettlement Act, 2013, the government was empowered to take such actions.
8. Even though the affected persons from the Yulur tribe took the compensation and shifted to the plains of Bongorajjo they filed a writ petition in the Supreme Court claiming violation of their rights as a tribe to forested land and for forceful eviction by the government of Faddyland *inter alia*.
9. Meanwhile the Central Government of Faddyland passed The Citizenship Amendment Act, 2019 by which The Citizenship Act, 1955 was amended. This statute gave eligibility for Indian citizenship to illegal migrants who belonged to minority religious groups. The Act however does not mention Muslims. Further the Yulur Tribe have always been suspected of being migrants from Jamladesh. And the fact that they do not possess identification documents has always weakened their case.
10. While the writ petition was pending, another development project was supported by the Central Government. This time the proposal was for setting up a pesticide plant, Bharat Pesticides Pvt. Ltd, by Mr. Bharat Singh from Bongorajjo who urged that it would also help in boosting the agricultural produce of the Yulur Tribe who were struggling with fighting pests on their agricultural land.
11. The Yulur Tribe members did not protest for the setting up of the pesticide plant since they were assured that no further deforestation would take place and that no further

member of the tribe would be asked to leave their place. However once the plant was set up, effluents from the plant were being released into the Dhiraj River and the tribe members started worrying for the health of their families and their crop-produce.

12. You are requested to prepare detailed written submissions/memorials on behalf of the side of the petitioner supporting the cause of the petitioner and also from the side of the respondent, being Republic of Faddyland arguing that the actions taken under the relevant laws are legally correct and valid and do not require any interference by the Supreme Court.

Instructions—

1. The laws of Faddyland are *pari materia* to the laws of India.
2. The facts of this Moot Proposition are purely a work of fiction and purely intended for academic purpose.
3. The participants are required to frame issues.
5. In addition to other relevant legal sources, the participants are encouraged to apply constitutional principles, environmental jurisprudence, and human rights principles to advance their arguments.
6. Participants may also refer to foreign judicial pronouncements, foreign doctrines and principles, but they must bear in mind that they will not be binding and will have persuasive value on the Supreme Court of Faddyland.

**RULES AND REGULATIONS OF MOOT COURT ORGANISED BY
DEPARTMENT OF LAW, BU IN ASSOCIATION WITH BURDWAN
UNIVERSITY LAW ALUMNI ASSOCIATION- 2022**

Article 1: The Selection Rounds

- a. The Competition will be held in three rounds: preliminary round, semi-final and finals all based on the same moot proposition.
- b. The Preliminary round will be in an online format on the google meet platform on 12th November, 2022 from 10 am to 3.30pm.
- c. The Semi Finals and Finals will take place on 19th November, 2022 from 11 am to 4.30pm at the Department of Law, The University of Burdwan, Golapbag Campus, Burdwan.
- d. The first stage of the competition shall be the **Preliminary Round** and the top Four Scorers, among all teams, will qualify for the **Semi-Final Round**.
- e. The Best Two teams from Semi-Final Round will participate in the Final Round. The highest scorer will be declared as the winner followed by the runner-up.
- f. A **draw of lots** will be done on **1st of November, 2022** to decide the order of competition for the respective participants and the schedule will be emailed to the respective participants by **2nd November, 2022**.
- g. Each participating team shall argue the case for either the petitioner or the respondent depending on the schedule chalked out from the draw of lots on **1st November, 2022**.
- h. There shall be a single judge for each Court selected from within the State of West Bengal which may include eminent Judges, lawyers and law teachers.

Article 2: Team Composition and Eligibility

- a. Each team shall consist of Two Counsels and One researcher. Each of whom:
 - As on 12.11.22 is a bona-fide undergraduate law students (for the year 2022-2023) of the Three Year Scheme or Five Year Scheme from an institution duly recognised by the Bar Council of India; and
 - as on the date of the start of the Competition has not been admitted to the unrestricted practice of law in any court.
- b. Each college shall send only One Team of such eligible participants.
- c. In no case the team shall consist of more than three participants. In case the concerned team makes it to the semi-final and final stage, the travelling expenses to Burdwan will be met by their respective institution.

Article 3: Registration.

- a. All participating teams shall register themselves by filling up the **Attached Registration form** along with the institutional certified **bona fide certificate** and email these documents to **bumootcourt2022@gmail.com** by midnight on **15th October, 2022**.
- b. All participating teams have to **mandatorily** obtain a **bona fide certificate** from their respective institution certifying their studentship and permission to participate for the event.
- c. All participating teams should send in the memorial for both the applicant and **respondent** by midnight of **31st October, 2022**.
- d. There is **no registration fee** for participation in the said moot court event.

Article 4: The Moot Proposition

- a. The moot proposition has already been emailed to the invited participants via email along with the brochure and rules and regulation.

Article 5: Memorials.

- a. Each team shall submit one soft copy of the Memorials, by email to the Organising committee on or before **31st October, 2022** midnight.
- b. The teams that make it to the Semi-Final and Final Round will have to submit 4 hard copies of each Memorial (Petitioner/Respondent) by **19th November, 2022, 11am** to the respective volunteer assigned to the Teams. (TC 1- Anwesha (7602186336); TC 4- Aditya (7407405840); TC 2: Chayan (7001489266) ; TC 3: Sudeshna (9083172878)
- c. Soft copies for both sets of parties for the preliminary rounds are to be submitted by 31st October, 2022 and no further change in the memorial shall be permitted afterwards.
- d. Hard copies for the semi-final rounds may be altered and submitted on 19th November, 2022 to the assigned team volunteer.
- e. The format of the Memorials is as follows:
 - Standard international A/4 size page
 - Font Type: Times New Roman, Font Size: 12, Double Spacing.
 - The Font Style of the Footnote should also be Times New Roman, Font Size: 10 and should be singly spaced.
 - Quotations from sources outside of the memorial of fifty words or more in any part of the memorial shall be block quotes (i.e., right and left indented) and must be single spaced.
- f. No indication shall be made for identifying the Institution/College of the participant and each team will be awarded a CODE NUMBER and that number alone shall be marked on the memorials. Team Codes have been separately emailed to the candidates.
- g. The petitioner and respondent memorials must be differentiated by Blue Colour Cover Page and Red Colour Cover Page respectively.
- h. Memorials for both sides should contain the following in order:
 - Title Page
 - Table of Contents
 - Index of Authorities
 - Statement of Jurisdiction
 - Statement of Facts
 - Summary of Arguments/Pleadings
 - Arguments Supported by the Authorities
 - Conclusion/Prayer.

Article 6: Assessment of the Memorials

- a. The memorials shall be assessed by a Committee of Judges and every memorial will be marked out of total of 100 marks. The Marking Criteria and the Marks Allocated to each Category are listed:
 - Knowledge of facts and law (20 pts)
 - Proper and articulate analysis (20 pts)
 - Extent and use of research (20 pts)
 - Clarity & Organisation (20 pts)
 - Citations of sources (10 pts)
 - Grammar and Style (10pts)

Article 7: Oral Presentations (Preliminary, Quarter, Semi-Final Round)

- a. The oral round for preliminary round shall consist of sixty (60) minutes of oral pleadings. Each team Petitioner/Respondent shall be allotted 30 minutes.
- b. The oral round for each semi-final stage shall consist of forty (40) minutes of oral pleadings. Each team Petitioner/Respondent shall be allotted twenty (20) minutes.
- c. Two members from each team shall make oral presentations during the round.
- d. In the Semi Finals, no single oralist shall plead for more than 10 minutes, excluding rebuttal or sub-rebuttal. Any team member may act as an oralist during any round of the competition. In exceptional circumstances, the Bench shall have the discretion to permit a single oralist to argue beyond 10 mins.
- e. The order of the pleadings in each round at all levels of the competition shall be: Petitioner 1, Petitioner 2, Respondent 1, Respondent 2, Rebuttal (Petitioner 1 or 2), Sub-Rebuttal (Respondent 1 or 2).

Article 8: Oral Presentations (Final Round)

- a. Each team will get a total of 30 minutes to present their case. This time will include time for rebuttal and sub-rebuttal.
- b. The division of time is at the discretion of the team members, subject to a maximum of 15 mins per speaker.
- c. The oral arguments need not be confined to the issues presented in the memorials.
- d. The researcher shall sit in the designated area while the speaker presents his/her case.

Article 9: Marking Criteria for the Oral Presentations.

- a. The judges would assign marks to each individual speaker out of 100 marks. The team score would be the average of the total marks for oral presentation of the 2 speakers out of the 100 marks. The following shall be the marking criterion and the marks allocated to each category.
 - Knowledge of Law (30 pts)
 - Application of Law to Facts (25 pts)
 - Ingenuity and Ability to Answer Questions (30 pts)
 - Style, Poise, Courtesy and Demeanour (10 pts)
 - Time Management and Organization (5 pts)

Article 10: Disputes

- a. Any dispute about the Moot Court Competition shall be referred to the Dispute Resolution Committee, comprising the Secretary of BULAA, Teacher-in-Charge of The Department of Law and Prof. Sanjeev Tiwari. In all matters of complaints or disputes, the decision of the Dispute Resolution Committee shall be final.

Article 11: Code of Conduct and Dress Code.

- a. The language for the Moot Court Competition shall be English.
- b. All participants are expected to maintain the decorum in the court by keeping themselves on mute in the online platform and likewise on the Campus on 19th November, 2022.
- c. Strict adherence to the Dress code is required for both the online participants and the offline participants. The participants are required to wear "Black Trousers" and "White Shirt"/"White Kurti", "Black Blazers"/"Black waist coat", and "Black neck tie".
