Online applications for admission to **self-financing** one year Diploma in Cyber Law Course of Study [Session 2023-2024], in AMEX LAW COLLEGE, Nawbabhat, Suri Road, Burdwan, are invited from the eligible intending applicants, through on-line mode from 04.08.2023 to 24.08.2023 in the online admission portal available in the University website (www.buruniv.ac.in) along with the Application fees of **₹500/- (Rupees Five Hundred only)**
2. **Course Fees: ₹16,000/- (Rupees sixteen thousand only) excluding University Examination Fees of ₹1000/- per student)**
3. **ABC ID:** ABC ID is mandatory field in admission form as per UGC order D.O. No. F. 1-50/2021(ABC/NAD) dated 21st February, 2023.

5. The candidates have to Pay ₹500/- (**Rupees Five Hundred only**), through online via **State Bank Collect (SB Collect)** by the following link. No communication in this regard will be entertained after the expiry of payment period. University will not take the responsibility of any payment failure caused due to network problems.

- (iii) **Select “Application fee Dip in Cyber Law- Amex Law College”** from the dropdown list under “**Payment Category**”, then enter your relevant details and proceed for payment as per the instructions on the page.
- (iv) Candidates are directed to take print out of Successful Payment Receipt and are required to submit the same during Verification of Documents.

On-line submission of application form by a candidate does not automatically ensure his/her admission to the Programme.

For EWS Candidates: Reservation for EWS candidates for admission will be as per reservation rules vide Govt. Order No. 325-PAR(AR)/3P-1/2019 dated 09/07/2019.

7. **Eligibility:** Any Graduate under 10+2+3 format of any stream from a UGC Recognized University.

8. Mode of Selection for Admission:

Seats in the one-year DIPLOMA IN CYBER LAW Course will be filled up on the basis of Grade Points to be calculated by adding 50% of UG or equivalent examinations’ Marks with 30% of HS or equivalent examinations’ marks and 20% of Madhyamik or equivalent examinations’ marks. In case of the equal Grade Points, the percentage of marks obtained by the candidate in Honours Degree is to be considered and calculated for determining the higher position in the merit list. In case of the uniform score in the concerned Honours Degree, the percentage of marks obtained by the candidate in Higher Secondary Examination is to be considered and calculated for determining the higher position in the merit list. If the percentage of Higher Secondary marks is also being the same, percentage of Secondary Examination will be considered for ranking. If, at all these stages, performances of more than one student are found to be same, then final decision regarding selection of candidate will be referred to Hon’ble Vice Chancellor, BU.

9. The University also reserves right to drop or include any name if any suppression of facts on the part of the applicants or any mistake in the calculation of grade point is detected at any stage before and after admission.

10. The date of commencement of class will be noticed later on.
