2. **Provisional admission shall be done strictly on the basis of merit. Provisional Broad Merit Cum Rank List for Ph.D. Programme 2023 in Law and Sanskrit** has already been published for information of all the concerned candidates vide Notification No. **FC(A)/Admission/Ph.D./2023/50, dated 12-07-2024 and FC(A)/Admission/Ph.D./2023/55, dated 22-07-2024** respectively.

3. **ALL ADMISSIONS ARE PROVISIONAL. Mere selection of candidates and payment of admission fees do not ensure confirmation of admission unless the eligibility of the candidates is checked, and original credentials are found in order at the time of verification of documents by the concerned departments.** If a candidate is found, before or after admission, not having the minimum eligibility of admission, then the university will have the right to cancel his/her admission without taking responsibility of refund of his/her admission fees. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students or any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.

4. In case a candidate does not fulfill the eligibility and merit criteria, he/she is requested **not to proceed** with the subsequent steps since it is likely that the admission will not be confirmed.

5. At the time of counseling all the candidates must produce their academic and other credentials in original.

6. The University reserves the right to rectify the list of candidates selected for admission in the event of detection of any inadvertent error, before or after payment of admission fees including cancellation of admission.

7. The candidates who will be provisionally selected for **Ph.D. Programme 2023 in Law and Sanskrit**, have to Pay Rs. **3400/- (Rupees Three thousand four hundred only)**, through online via **State Bank Collect (SB Collect)** on and from **25-07-2024 to 27-07-2024** by the following link. No communication in this regard will be entertained after the expiry of payment period. University will not take the responsibility of any payment failure caused due to network problems.

AND proceed with the following steps:

- (i) Provisionally Selected Candidates are to select “**Educational Institutions**” under “**Select Category**”.
- (ii) **Search for “The University of Burdwan”** in the “**Name of Educational Institutions**” and **Click on “The University of Burdwan”**.
- (iii) **Select “ADMISSION FEES FOR PH.D. PROGRAMME 2023”** from the dropdown list under “**Payment Category**”, then enter your relevant details and proceed for payment as per the instructions on the page.
- (iv) Candidates are directed to take print out of Successful Payment Receipt and are required to submit the same during Verification of Documents.

8. **Classes for the Ph.D. Programme 2023 in Law and Sanskrit under Faculty Council (Arts, etc.) will commence from 29-07-2024.**

9. **All the Provisionally Selected Candidates for Ph.D. Programme 2023 in Law and Sanskrit, after successful payment, must complete the document verification in the concerned department on and from 29-07-2024 to 31-07-2024 for the confirmation of admission.**

10. **If any candidate or his/her authorized representative fails to turn up on the stipulated date and time of counseling, will not be considered for admission in the later stage.**

11. **Non-payment of admission fees by the selected candidates within the stipulated time shall amount to cancellation of his/her candidature and in such context, they will be debarred from participation in any subsequent phase of the admission process.**

12. **Seats are limited and will be available on the basis of merit and hence, mere participation in the counseling does not ensure seats to the candidates as number of seats are lesser than the number of applicants.**

13. **As per the reservation rules vide Govt. Order No.: 07-Edn (U)/1U-89/13.-dated. 2nd January, 2014 “for admission to different courses, SC or ST candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 25% of the marks obtained by the last candidate of the general category. In case of OBC-A and OBC-B the candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 10% from the marks obtained by the last candidate of the general category.”**

14. **Guidelines of Inter-Transferability of Reserved Seats:**

(a) In case seats reserved for S.C. Category remain vacant for want of eligible candidates, seats will be filled up by the eligible candidate from the list of S.T. Category and vice-versa.

(b) In case seats reserved for OBC-A Category remain vacant for want of eligible candidates, seats will be filled up by the eligible candidate from the list of OBC-B Category and vice-versa.

15. **The aspirants who have applied for admission to Ph.D. Programme 2023 in Law and Sanskrit, seeking reservation under Economically Weaker Section (EWS) category, are required to submit the original EWS Certificate of the current Financial Year (2024-25) positively during counseling, failing which their admission under EWS Category will not be considered.**

16. As per the directives of the Hon'ble Supreme Court of India, it is notified that if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institution.

17. **Seats remaining vacant after the expiry of payment period will be filled up through another Notification for Counseling (Phase-2) which will be published later. Please visit the university website for any update.**
