1. The tenderer shall be an original item Manufacturer or qualified Indian Agents.
2. Tender should not be submitted by the firm/company for the Product(s) for which the firm/ Company has been blacklisted/ banned/ debarred by CMSS/ State Governments/ Central Government/ its Drug procurement agencies or if the Firm/Company is debarred as a whole by these agencies.
3. All prices should be quoted in Indian Rupees only.
4. Prices are to be quoted inclusive of GST.
5. Delivery of chemicals should be free of charges.
6. The vendor should indicate specifically the basic price, taxes and other charges against each item.
7. GOODS & SERVICES TAX (GST): The Tenderer may quote for GST as per applicability in accordance with relevant Government notification.
