

**(For supply of Consumable items)**

Department of Zoology invites sealed quotations for procurement of **consumables (Annexure-1)** for ANRF (formerly DST-SERB), GOI, sponsored Research Grant, Pl. **Dr. Arup Mistri**. The tentative quantity and the required items of each are mentioned at **Annexure-I** separately. The quotations complete in all respects, must be submitted to: **Dr. Arup Mistri, Pl, DST- SERB Project, Department of Zoology, The University of Burdwan, Burdwan 713 104, India** on or before **04.00 p.m. of 25.09.2025**.

1. Prices are to be quoted preferably in INR, and inclusive all taxes / charges. Rates quoted should be valid for acceptance for at least 6 months from the date of submission to the office of the university.
2. The University reserves the right to select the brand at its own discretion. The University is not bound to accept the lowest rate and reserve the right to accept or reject any or all the quotation without assigning any reason whatsoever.
3. Items should be delivered within 30 days after placing the formal order, failing which the order shall stand cancelled.
4. The supplier shall be liable to such penalties as the university may decide in case of failure on the part of supplier to complete the supply of the items within such period as may be specified in the supply order.
5. The University will not accept any substandard articles under any circumstances.
6. Payment due to the supplier will be made through the R.T.G.S. direct to the party bank account.
7. A vendor may submit quotation for a single item or for all.
8. The University is not bound to accept the lowest rate and reserves the right to cancel any of the quotations or all the quotations without assigning any reasons
9. All documents must be put into a sealed envelope which should be superscribed with Quotation Notice No.
10. Tender should contain copies of the following documents: -

  - Copies of the Income Tax Acknowledgement Receipt of assessment year, 2024-25 P.T. Deposit Challan for latest year
  - Trade License
