1. INTRODUCTION

Online applications are invited from the eligible intending candidates for admission to the 3-Year LL.B.(H) Course of Studies (Session: 2025-2027) [BCI Session: 2024-2025] under Faculty Council (Arts, Commerce, Law etc.), The University of Burdwan. Online form will be available on the University website (www.buruniv.ac.in) on and from 17.09.2025 to 30.09.2025 in the online admission portal available on the University website (www.buruniv.ac.in).

Payment of application fees [Rs. 250/- + transaction charge (if any)] will have to be paid online mode. Candidates are advised to take the printout of the e-challan of payment made.

4 GENERAL ELIGIBILITY CRITERIA

• For Unreserved Category candidates at least 45% marks in the Bachelor's Degree under 10+2+3/10+2+4 pattern, for OBC-A/OBC-B Categories 42% marks in the Bachelor's Degree under 10+2+3/10+2+4 pattern and for SC/ST Categories 40% marks in the Bachelor's Degree under 10+2+3/10+2+4 pattern or 45% marks in the Master's Degree for all Categories.

5 AGE LIMIT

 No age limit but the entire process including admission to the course shall abide by the judgment of the Hon'ble Supreme Court in WP (Civil) No.-1023/2016, which is still pending.

6 RESERVATION

• For the Department of Law, The University of Burdwan and Government Centre of Legal Education (Hooghly Mohsin College), 22% and 6%, of total seats will be kept reserved for SC and ST candidates respectively, D.A. candidates will enjoy a 5% reservation in each of the categories, i.e. in SC, ST and in the Unreserved (UR) category. There shall be provision for 01 (One) SP Quota in University Campus.

Schedule Caste & Schedule Tribes:

Reservation for SC/ST candidates for admission will be as per reservation rules vide Govt. Order No.: 07-Edn (U)/1U-89/13.- dated. 2nd January, 2014 "for admission to different courses, an SC or ST candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 25% of the marks obtained by the last candidate

of the general category." Relevant Certificate must conform to West Bengal Govt. Memo No. 1813-BCW/MR-94/11 dated 20th June, 2011. Candidates claiming reservation against SC/ST and OBC-A/OBC-B (relevant certificate is required) quota of seats must submit relevant caste certificates issued in their favour by one of the authorities listed below:

- Kolkata Collector of Stamp Revenue,
- Kolkata Metropolitan Magistrate, Kolkata,
- Addl. Chief Metropolitan Magistrate, Kolkata,
- Chief Metropolitan Magistrate, Kolkata,
- 1st Class Stipendiary Magistrate,
- Executive Magistrate,
- Sub-Divisional Magistrate,
- Sub-Divisional Officer,
- Deputy Collector,
- Addl. District Magistrate,
- Collector and District Magistrate within their respective jurisdictions in case of candidates claiming

to be Schedule Caste or Schedule Tribe and ordinarily residing within such jurisdictions.

OBC-A & OBC-B:

There is no reservation for OBC-A/OBC-B candidates for admission to 3-year LL.B. (Honours) Course of Studies as per the rules of the Bar Council of India. But if any candidate belonging to OBC-A/OBC-B category, having less than 45% marks in graduation, intends to apply for admission to 3-year LL.B. (Honours) Course of Studies, must have to upload the OBC-A/OBC-B certificate, issued by the competent authority under the Govt. of West Bengal to avail the benefit available for the OBC-A/OBC-B candidates for eligibility criteria.

<u>Differently Abled</u>:

The candidates seeking admission under this category must upload, along with the online application for admission to the said course, a valid certificate issued by an appropriate authority not below the rank of Superintendent of Sub-Divisional Hospital. In the certificate, the mentioned extent of Physical Disability must not be less than 40%.

Sports Personality:

Sports quota will be available only for the candidates who have passed out from the University of Burdwan seeking admission to the said course. Candidates, seeking admission against Sports (SP) quota of seats, must have to upload the certificates of their participation in National or Inter-University Sports and Athletic competitions (not earlier than Madhyamik level) and physically fit for representing the University team in AIU Games as per AIU norms. If in the SP category more than 1 (One) candidate qualifies then the ranking in Sports quota will be made on the basis of higher marks obtained in the Written Test.

For EWS Category Candidates:

• Reservation for EWS candidates for admission will be as per reservation rules vide Govt. Order No.: 339-Edn (CS)/OM-74L/2023 - dated. 26th May, 2023, issued by Department of Higher Education, 6th Floor, Bikash Bhavan, Kolkata-91. Candidates claiming reservation against EWS Category (relevant certificate is required) quota of seats must submit the relevant EWS certificates issued in their favour by one of the authorities as per O.M. No. 325-PAR (AR)/3P-1/2019 dated 09.07.2019 of Personnel & Administrative Reforms, Govt. Of West Bengal and Memo No. 959-BCW/MR-52/2019 dated 18.05.2023 of Backward Classes Welfare Department, Govt. Of West Bengal.

7 MODE OF SELECTION FOR ADMISSION

The selection for admission to the course shall be made strictly on the basis of performance of the eligible candidates in the Written Admission Test to be conducted by the University on <u>15.10.2025</u> (<u>Tuesday</u>) from 12 noon at the Composite Building, Golapbag Campus of the University. Admission Test shall be of 100 marks consisting of English (80 Marks) & General Knowledge (20 Marks).

- ❖ The Admit Card for the Written test will be downloaded on and from 08.10.2025 by logging in to the Student Dashboard.
- Provisional Admission will be made through counselling on the basis of merit and the date of the counselling will be notified later.
