Instruction to bidders

1. Eligibility criteria:

- a. The tenderer shall be an original item Manufacturer or qualified Indian Agents.
- b. Tender should not be submitted by the firm/company for the Product(s) for which the firm/ Company has been blacklisted/ banned/ debarred by CMSS/ State Governments/ Central Government/ its Drug procurement agencies or if the Firm/Company is debarred as a whole by these agencies.

2. General conditions:

- a. A complete set of Tender documents may be downloaded by any interested eligible tenderer from website: <https://www.buruniv.ac.in> as per the schedule given in Critical Date Sheet. No cost for the Tender document shall be charged for the Tender documents downloaded by the Tenderers.
- b. Any person who has submitted the Tender document should watch for amendments, if any, on the website: www.buruniv.ac.in; for which BU will not issue any separate communication to them.
- c. **The categories of items and quantity indicated in the tender document are tentative. BU, however, reserves the right to increase or decrease the quantity or delete some or all the items depending on the needs of the PI and availability of funds without assigning any reasons.**
- d. The bidder should clearly indicate the delivery period and validity period of the tender. It may be mentioned that the validity period of the price should be at least six months (180 days).
- e. Both Technical Bid and Financial Bid are to be submitted within the closing date of submission.

3. Techno commercial bid

- a. Tenderer shall be a manufacturer or its qualified Indian Agent. In case the bidder is a manufacturer- Self Declaration of Manufacturer should be given.
- b. **All the prices must be quoted in INR only.**
- c. The bidder should indicate specifically the basic price, taxes and other charges against each item.
