"Online Session for merit-based selection/allotment of candidates for subjects offered through multiple centre of learning"

Subjects: Bengali, Commerce, English, History, Political Science, Sanskrit, LLM, M. P. Ed., and MBA programmes] offered in different centres of learning (BU campus and affiliated Colleges, for the remaining vacant seats)

All the eligible candidates of the aforementioned subjects who have applied for admission (with successful submission status) to the various PG courses offered by multiple centres of learning (i.e., Golaphag campus and affiliated colleges where PG courses are conducted) under the Faculty Council (Arts) of BU for the session 2021-2023, are asked to attend the session positively for merit-based selection as per the following schedule:

The candidates should take note of the following instructions:

1. The online session through Google meet is being conducted only for merit-based selection/allotment of candidates based on eligibility and merit criteria.

2. **All eligible candidates as per the ranks mentioned in this notification,** who have successfully submitted application forms online and who intend to study in the subjects offered through multiple centres of learning to be allotted based on merit, **should compulsorily attend online session through Google meet**.

3. Candidates should enter their respective Google Meet room at the scheduled time and wait for the administrator to admit them.

4. Candidates who do not log in and attend the session at the stipulated date and time will be marked as ABSENT.

5. Candidates must join the session by using the subject-wise and schedule-wise specific google meet link provided in this notification.

- 6. Candidates must ensure that they are having good Internet connectivity during the session.
- 7. Candidates shall keep their academic testimonials (including all marksheets and certificates) and SC/ST/OBC certificates (for the concerned candidates) in original with them. They will be required to produce the documents during the online session.
- 8. All the candidates who have been asked to appear in the online session must ensure that their cell phones corresponding to the number mentioned during form filling-up are not switched off. They should be ready to accept the phone calls to be given by the office, if needed.
- 9. In case a candidate is unable to online attend, he/she should send his/her authorised representative for the session.
- 10. The mere fact that a candidate has been asked to appear in the session doesn't assure selection <u>unless seats are available</u>. Hence, all candidates are asked to check the subject-wise vacancy position before attending the session.

- 11. Once the merit-based selection is completed, payment link for payment of the requisite admission fees will be available for the selected candidates through the online link from the next day of online session and will be live upto midnight of the fourth day. In case of any issue/problem regarding payment, candidates should contact us immediately and definitely before the expiry of payment period (email: pgadmissionarts@buruniv.ac.in). No communication in this regard will be entertained after the expiry of payment period.
- 12. Students should ensure collection of E-receipt of successful payment generated in the online system or SMS sent from the University to their registered mobile no. or through e-mail to their registered e-mail id of candidates with "Successful" payment status. Mere receipt of SMS from own bank is not sufficient to ensure successful payment. The University will not take the responsibility of any payment failure caused due to network problems. So, candidates are advised to check their "Successful" Payment status.
- 13. After the expiry of payment period, the list of the candidates having "Successful" Payment Status will be published on the university website. The candidates with unsuccessful payment status/payment failure along with the selected candidates who could not make their payments due to technical reasons, will be provided with an opportunity to make payments on the next day after the payment report will be published.
- 14. Candidates will be enlisted based on the merit-based selection on the basis of the vacancy position.
- 15. The selected candidates should report to their respective departments with the e-receipt of their admission Fees on or one day after the payment of admission fees.
- 16. **Document verification** for the selected candidates will be carried out later on by the concerned department where the candidate will be selected after the conclusion of the session and after payment of admission fees through on-line mode for the respective centre of learning. All the selected candidates who have successfully paid the admission fees will have to produce and submit self-attested photocopies of **all** testimonials including the relevant certificates and final honours mark sheet **on the date of document verification**, failing which their admission to Post Graduate courses will be cancelled. All eligibility criteria will be checked during document verification. If, at the time of document verification, the marks obtained by the candidate doesn't match with the marks shown in the merit list, the admission of the candidate is liable to be cancelled.
- 17. The broad rank list has been prepared based on system generated data without actual document verification. Candidates are therefore requested to verify their eligibility in accordance with the criteria as prescribed in the Information Brochure of the PG Admission 2021, available in the University Website.
- 18. In case a candidate does not fulfil the eligibility and merit criteria, he/she is requested not to proceed with the subsequent steps since it is likely that the admission will not be confirmed.
- 19. ALL ADMISSIONS ARE PROVISIONAL. Mere selection of candidates and payment of admission fees do not ensure confirmation of admission unless the eligibility of the candidates is checked and original credentials are found in order at the time of verification of documents. If a candidate is found, before or after admission, not having the minimum eligibility of admission, then the university will have the right to cancel his/her admission without taking responsibility of refund of his/her admission fees. The University also reserves all rights to drop or to include any name, if any suppression of facts on the part of the students, any mistake on the part of the University or any error in the system-generated data is detected at any stage before or after the admission.
- 20. ADMISSION OF THE SELECTED CANDIDATES WILL BE CONFIRMED ONLY AFTER DOCUMENT VERIFICATION TO BE UNDERTAKEN IN BLENDED MODE AFTER PAYMENT OF ADMISSION FEES. Please follow our subsequent instruction for document verification which should be complied with by all the relevant candidates.
- 21. Candidates who have paid admission fees should contact the HoDs/TICs of the respective departments/Centre of Studies through email immediately after payment with a copy of the payment receipt as an attachment.
- 22. If there is no candidate in the UR-DA, SP Category, then the seat will be transferred to the UR Category. Under similar circumstances, seats of DA-SC, DA-OBCA will be transferred to SC and OBCA Category respectively. As per the reservation rules vide Govt. Order No.: 07-Edn (U)/1U-89/13.- dated. 2nd January, 2014 "for admission to different courses, an SC or ST candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 25% of the

marks obtained by the last candidate of the general category. In case of OBC-A and OBCB the candidate getting admission should have obtained in the previous examination; qualifying marks not lower by more than 10% from the marks obtained by the last candidate of the general category."

- 23. Guidelines of Inter-Transferability/Conversion of Reserved Seats:
 - 23.1 In case seats reserved for S.C. Category remains vacant for want of eligible candidates, seats will be filled up by the eligible candidate from the list of S.T. Category and vice-versa. If the seats of reserved Category remain vacant even invoking the principle of inter-transferability may be converted to seats under UR Category as per Govt. Rules.
 - 23.2 In case seats reserved for OBC-A Category remains vacant for want of eligible candidates, seats will be filled up by the eligible candidate from the list of OBC-B Category and vice-versa. If the seats of reserved Category remain vacant even invoking the principle of inter-transferability may be converted to seats under UR Category as per Govt. Rules.
 - 24. The University reserves the right to rectify the list of candidates selected for admission in the event of detection of any inadvertent error, before or after payment of admission fees including cancellation of admission.
 - 25. As per the directives of the Hon'ble Supreme Court of India, it is notified that if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the institution.
 - 26. For subjects with multiple centres of learning (BU campus and affiliated colleges), candidates will be upgraded on the basis of available vacancy if any, merit, preference given by the candidate. The candidates who opt for upgradation should contact the HoDs/TiCs of the respective centre of learning at the upgraded centre since due to upgradation and their acceptance therein, their previous allocation would stand as cancelled. The upgraded candidates have to pay admission fees as per the following:

If the admission fee of the centre where the candidate has been upgraded is more than the admission fees of the centre from where the candidate is being upgraded, the candidate has to pay the balance amount of the admission fees of the centre where the candidate has been upgraded.

- If the admission fee of the centre where the candidate has been upgraded is lesser the admission fees of the centre from where the candidate is being upgraded-the candidate has not to pay any amount. The remaining amount will be refunded to the concerned candidates in due course as per university rule.
- 27. As already notified, non-payment of admission fees by any selected candidate of the Provisional Merit List (Allocation List Phase 1) shall amount to cancellation of his/her candidature and in such context, they will be debarred from participation in any round of the admission process.
- 28. Selected candidates of the provisional merit list can get access for payment by logging in into the dashboard of the admission portal of The University of Burdwan by putting their applicant id and password through the Students Dashboard.
