2. **Course Fees: ₹16,000/- (Rupees sixteen thousand only) per annum excluding University Examination Fees of ₹1000/- per student)**

4. **Payment of application fees [₹1000/- + transaction charge (if any)]** will have to be paid to the Account details given below after successful submission of the online application form in between the above mentioned dates, no communication in this regard will be entertained after the expiry of payment period. 6. Eligibility: Any Graduate in 10+2+3 format of any stream from a UGC Recognized University.

7. Mode of Selection for Admission:

Seats in the one year DIPLOMA IN CYBER LAW Course will be filled up on the basis of Grade Points to be calculated by adding 50% of UG or equivalent examinations' Marks with 30% of HS or equivalent examinations' marks and 20% of Madhyamik or equivalent examinations' marks. In case of the equal Grade Points, the percentage of marks obtained by the candidate in Honours Degree is to be considered and calculated for determining the higher position in the merit list. In case of the uniform score in the concerned Honours Degree, the percentage of marks obtained by the candidate in Higher Secondary Examination is to be considered and calculated for determining the higher position in the merit list. If the percentage of Higher Secondary marks is also being the same, percentage of Secondary Examination will be considered for ranking. If, at all these stages, performances of more than one student are found to be same, then final decision regarding selection of candidate will be referred to Hon'ble Vice Chancellor, BU.

10. The University also reserves right to drop or include any name if any suppression of facts on the part of the applicants or any mistake in the calculation of grade point is detected at any stage before and after admission.

11. Classes for the aforementioned subject will commence from 07/12/2022.
