In furtherance to extant circulars / notification relating to Free-ship / award of tuition fees concession for the academic year 2020 – 2021, it is hereby notified for information of all concerned that applications are called for Free-ship / award of Tuition Fee Concession (half / full) for the academic year 2020 – 2021:

01. Students applying for free-ship / award of Tuition Fee Concession (half / full) shall apply through prescribed Application Form seeking waiver / concession of tuition fee (fresh or renewal) which is annexed alongwith / available on the University of Burdwan website (www.buruniv.ac.in) for easy access / download by the students of the University.
02. The students of 1st and 2nd Year P.G. courses are to submit their application seeking free-ship / award of tuition fee concession (half / full) to the Head of the Department concerned within 15 days from the date of notice along with supporting income certificate of their guardian issued by the appropriate authority.
03. Considering COVID19 situation students applying for free-ship / award of Tuition Fee Concession may forward scanned copy of filled in application form along with income proof certificate to the email id of their respective HOD for necessary recommendation and forwarding to the Placement & Students Welfare department.
04. The Head of the Department(s) shall accordingly forward the list of candidates eligible for free-ship / concession of tuition fee (half / full), along with necessary enclosures in hardcopy to the Placement & Students Welfare office as per below mentioned format:
