





Dear Candidate,

I am pleased to inform you that based on the National Eligibility Test (UGC-NET) for Junior Research Fellowship and Eligibility for Assistant Professor conducted in June 2019, you have been identified for award of fellowship under the scheme of **National Fellowship for Scheduled Caste Students for the year 2019-20**.

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC, i.e., 27.12.2019 (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

The candidate is required to get admission and registration for regular and full time M.Phil/Ph.D. course in a University/Institution recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of scheme and Notification dated 27.12.2019. The same can be accessed at https://www.ugc.ac.in/ugc_notices.aspx.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

For the e-Certificate of Eligibility for Assistant Professor, the candidate may visit the website of National Testing Agency (NTA). The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
