In response to your application dated 07.09.2023, I am directed to inform you that Hon'ble Vice-Chancellor has been pleased to allow you to join the UGC-National Fellowship for Scheduled Caste Students under the Department of **Hindi**, The University of Burdwan, for pursuing Ph. D. Programme with effect from 29.07.2023.

The tenure of the fellowship is initially for two years under the UGC-National Fellowship for Scheduled Caste Students scheme. Upon expiry of this period, the research work will be evaluated by experts. If the research work will be found satisfactory, the tenure of the fellowship will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF) as per the norms framed by the UGC.

Phil. /Ph.D. shall be subject to the revision of University regulation regarding M. Phil. /Ph. D. registration in accordance with the U.G.C. guidelines.

I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the **June 2020** National Eligibility Test (UGC-NET), you have been selected for award of fellowship under the scheme of 'National Fellowship for Scheduled Caste Students' for the year 2020-21 (June Cycle).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC i.e. 30.11.2020 (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for UGC-NET, you have not taken admission for M.Phil/Ph.D. Accordingly, you are required to get admission and registration for regular and full time M.Phil/Ph.D. course in a University/Institution recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of the Scheme and Notification dated 17.12.2020. The same can be accessed at https://www.ugc.ac.in/ugc_notices.aspx.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (https://scholarship.canarabank.in) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on https://ugcnet.nta.nic.in. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
