- e) You will have to submit your thesis within six years from the date of your registration for Ph.D. degree mentioned above, but not earlier than 21.01.2025 (three years including course work) in the prescribed manner along with the fee of Rs. 8,000/- (Eight thousand only) or as may be fixed by the Executive Council from time to time towards submission of thesis.
