In response to your application dated 14.01.2021, I am directed to inform you that Hon'ble Vice-Chancellor has been pleased to allow you to join the **UGC-National Fellowship for Scheduled Caste Students** under the Department of Bengali, The University of Burdwan, for pursuing research work with effect from 30.11.2020.

The tenure of the fellowship is initially for two years under the UGC-National Fellowship for Scheduled Caste Students. Upon expiry of this period, the research work will be evaluated by experts. If the research work will found satisfactory, the tenure of the fellowship will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF) as per the norms framed by the UGC.

You are entitled to get fellowship and all financial assistance allotted by the University Grants Commission through Bank from the date of receiving of the UGC-National Fellowship for Scheduled Caste Students (or) from the date of Registration under M. If you agree to accept the offer, you would be required to join the said fellowship within thirty days from the date of issue of this letter on submission through the Head of the Department of a formal letter of acceptance of the condition and four copies of joining report, however, your registration for being M. Phil. /Ph.D. shall be subject to the revision of University regulation regarding M. Phil. /Ph. D. registration in accordance with the U.G.C. guidelines.



I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the June 2020 National Eligibility Test (UGC-NET), you have been selected for award of fellowship under the scheme of 'National Fellowship for Scheduled Caste Students' for the year 2020-21 (June Cycle).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC i.e. 30.11.2020 (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for UGC-NET, you had already taken admission for M.Phil/Ph.D through regular and full time mode in a UGC recognized University / Institution. Accordingly, you are required to apply for fellowship not later than three months from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of the Scheme and Notification dated 17.12.2020. The same can be accessed at https://www.ugc.ac.in/ugc_notices.aspx.

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ugcnet.nta.nic.in>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.
