



I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the June 2020 Joint CSIR-UGC Test, you have been selected for award of fellowship under the scheme of **Maulana Azad National Fellowship for Minority Students - 2020-21**.

The tenure of the Fellowship is five years and it commences from the date of declaration of result of Joint CSIR-UGC Test, i.e., **04.02.2021** (or) from the date of admission under M.Phil./Ph.D. (or) from the date of joining M.Phil./Ph.D. programme, whichever is later.

As you had not taken admission for M.Phil./Ph.D. while applying for Joint CSIR-UGC Test, you are required to get admission and registration for regular and full time M.Phil./Ph.D. course in a University/Institution recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of scheme and Notification dated **29.09.2021**. It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process is available at [https://www.ugc.ac.in/ugc\\_notices.aspx?id=2153](https://www.ugc.ac.in/ugc_notices.aspx?id=2153)).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ecertificate.nta.ac.in/>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.

With reference to your application dated 13.06.2022 for joining in Research Fellowship under the scheme of *Maulana Azad National Fellowship for Minority Students- 2020-21*, I am to inform you that you have been selected as a U.G.C-M.A.N. Junior Research Fellow in the Department of Zoology of this University.

The Fellowship will be governed by Guidelines for the Scheme of Maulana Azad National Fellowship for Minority Students (With effect from 2019-2020), ("The tenure of Fellowship is initially for two years under the JRF scheme. After two years, if the progress in the research work of the awardee is found satisfactory, his/her tenure will be extended for a further period of three years as Senior Research Fellow (SRF). The research work will be assessed as per the UGC norms. The total period of award of JRF and SRF shall not exceed a period of 5 years").

The amount of the Fellowship is as per the rules of UGC and HRA (as per the rules of the University). Further, you will be entitled to contingency grant as per the rules of UGC.
