I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the Joint CSIR UGC-NET December 2022 & June 2023 (merged cycle) exam, you have been selected for award of fellowship under the scheme of National Fellowship for Scheduled Caste Students (NFSC).

The tenure of the Fellowship is five years and it commences from the date of declaration of result for NFSC, i.e., 25-Jul-2023 (or) from the date of admission under M.Phil/Ph.D (or) from the date of joining M.Phil/Ph.D programme, whichever is later.

As per information provided by you while applying online for Joint CSIR UGC-NET, you have not taken admission for M.Phil/Ph.D. Accordingly, you are required to get admission and registration for regular and fulltime M.Phil/Ph.D course in a University / Institutions recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of National Fellowship for Scheduled Caste Students available at <https://socialjustice.gov.in/> & <https://www.nsfdc.nic.in/>

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. Initially, the awardee is to register at Scholar's Corner available at Scholarship & Fellowship Management Portal (SFMP) (<https://scholarship.canarabank.in/>). The Universities / Institutions will link the data of the awardee with the Master Data on the SFMP with their unique Maker and Checker IDs. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the awardee on monthly basis. Based on the data updated on SFMP by the concerned Universities / Institutions, the payment of the fellowship will be made to the awardee.

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ecertificate.nta.ac.in/>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.

With reference to your application for joining in Research Fellowship, I am to inform you that you have been selected as a U.G.C Junior Research Fellow in the Department of Zoology of this University.

The Fellowship will be governed by UGC guidelines, ("The tenure of Fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the Fellow will be evaluated by experts. If the research work is found satisfactory, his/ her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF)."

"In case the work for the first two years is not found satisfactory, an additional year will be given to him/her for improvement. However, during this period he/she will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years and if improvement is found, the fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, will no further provision of extension" (XIIth Plan guidelines, UGC) or subject to the condition as set forth by the University/ UGC and as may be laid down by the appropriate authority from time to time.

The amount of the Fellowship is as per the rules of UGC and HRA (as per the rules of the University). Further, you will be entitled to contingency grant as per the rules of UGC.

"The fellowship amount shall be disbursed through Canara Bank to the bank account of the awardee (any bank) directly"

If you agree to accept the offer, you would be required to join as a JRF within fifteen days from the date of issue of this letter on submission through the Head of the Department of a joining report (in triplicate) in prescribed form (for UGC Fellowship) – accepting the said conditions and mentioning the name of your guide therein.
