I am pleased to inform you that based on your qualifying for Eligibility for Assistant Professor in the June 2021 Joint CSIR-UGC Test, you have been selected for award of fellowship under the scheme of National Fellowship for Other Backward Classes (NFOBC), which is being funded by the Ministry of Social Justice and Empowerment, New Delhi.

The tenure of the Fellowship is five years and it commences from the date of declaration of result of Joint CSIR-UGC Test i.e., 24.03.2022 (or) from the date of admission under M.Phil./Ph.D. (or) from the date of joining M.Phil./Ph.D. programme, whichever is later.

As you had not taken admission for M.Phil./Ph.D. while applying for Joint CSIR-UGC Test, you are required to get admission and registration for regular and full time M.Phil./Ph.D. course in a University/Institution recognized by UGC at the first available opportunity but not later than three years from the date of issue of this award letter. The University/Institution is requested to process for award of fellowship based upon this letter, in accordance with the Guidelines of National Fellowship for Other Backward Classes available at www.ugc.ac.in

It may be noted that the fellowship amount shall be disbursed through Canara Bank to bank account of the awardee (any bank) directly. UGC has developed a dedicated web portal (<https://scholarship.canarabank.in>) for capturing data of the awardee. The Universities/Institutions will link the data of the awardee with the master data on the UGC web portal with unique Maker and Checker IDs which have already been provided to them along with the passwords. The Universities/Institutions shall update the information on the master data (regarding monthly payment confirmation, HRA, up-gradation, resignation etc.) of the beneficiaries on monthly basis. Based on the data updated on UGC web portal by the concerned Universities/Institutions, the payment of the fellowship will be made to the beneficiaries (Detailed process available at https://www.ugc.ac.in/ugc_notices.aspx?id=2153).

The e-Certificate of Eligibility for Assistant Professor has already been uploaded on <https://ecertificate.nta.ac.in>. The eligibility of the candidate for availing the fellowship is to be ensured by the University/Institution.

Dear Candidate,

With reference to your application for joining in Research Fellowship, I am to inform you that you have been selected as a U.G.C Junior Research Fellow under the scheme of *National Fellowship for Other Backward Classes (NFOBC)* in the Department of Botany of this University.

The Fellowship will be governed by UGC guidelines, ("The tenure of Fellowship is initially for two years under the JRF scheme. Upon expiry of this period, the work of the Fellow will be evaluated by experts. If the research work is found satisfactory, his/ her tenure will be extended for a further period of three years under the enhanced emoluments of the Senior Research Fellowship (SRF).

"In case the work for the first two years is not found satisfactory, an additional year will be given to him/her for improvement. However, during this period he/she will be designated as a Junior Research Fellow. In such case work will be evaluated again after three years and if improvement is found, the fellow will get two more years under the SRF. Thus, the total period of fellowship (JRF and SRF) is five years, will no further provision of extension" (XIIth Plan guidelines, UGC) or subject to the condition as set forth by the University/ UGC and as may be laid down by the appropriate authority from time to time.

The amount of the Fellowship is as per the rules of UGC and HRA (as per the rules of the University).

Further, you will be entitled to contingency grant as per the rules of UGC.

"The fellowship amount shall be disbursed through Canara Bank to the bank account of the awardee (any bank) directly"

If you agree to accept the offer, you would be required to join as a JRF within fifteen days from the date of issue of this letter on submission through the Head of the Department of a joining report (in triplicate) in prescribed form (for UGC Fellowship) – accepting the said conditions and mentioning the name of your guide therein.
